To sustain and strengthen cross sector collaborative, data-driven efforts across the Sunshine Coast, Wide Bay, and Central Queensland to improve health outcomes for people experiencing homelessness.

Description of Activity *

Existing Advance to ZERO initiatives will continue to expand and evolve in the Sunshine Coast, Wide Bay, and Central Queensland regions. Advance to ZERO is an internationally recognised best-practice approach where health, homelessness, and housing providers collaborate to collect consistent real-time data on the health and housing needs of people experiencing homelessness. This locally driven collaborative work not only supports the development of a shared, robust dataset but the data is used by the ZERO service coordination groups—including primary healthcare—to ensure people have access to the support they need to

improve health, identify system failures across the health, housing and homelessness service systems, work collaboratively to address the identified system gaps to ultimately improve access to health, housing, and homelessness services locally. It also maximises the efficiency of existing investments, and strengthens the coordination of care across the service system to improve the health and wellbeing of the target population.

Improve and support healthcare access for Culturally and Linguistically Diverse (CALD) communities

Description of Activity *

People from multicultural backgrounds, particularly non-English speaking background, often face additional barriers to accessing and navigating the health system, including language barriers, health literacy challenges, cultural safety and appropriateness of available health services, stigma and discrimination, socioeconomic and systemic factors.

CCQ is currently implementing the Resilient Care program across five Local Government Areas (LGAs) in Wide Bay and Central Queensland. The program focuses on building strong relationships with primary care providers, other care providers, communities, and key organisations including local government bodies to help protect and promote the health of vulnerable populations against climate and health risks including multicultural populations. This new initiative, Resilient Care - Multicultural, builds upon the existing Resilient Care partnerships and collaborative networks to address broader healthcare access issues for multicultural groups beyond climate and disaster focus. By leveraging these established foundations, the new program is efficient and delivers exceptional value for money to improve health of multicultural populations.

This program will include conducting a needs assessment to identify and prioritise CALD populations and geographic locations, their healthcare access barriers, cultural gaps, and service gaps. Co-design workshops will be facilitated with stakeholders to

collaboratively develop culturally appropriate service solutions to address barriers and needs for this cohort, to be commissioned by CCQ.

Increase and improve after hours service availability for priority populations.

Support existing models of care that increase accessibility, affordability and continuity of care in the after hours period.

Description of Activity *

There are complex and interconnected determinants that provide enablers and barriers for consumers to access appropriate health care services at the right place, and at the right time.

Often, emergency departments (EDs) are used as a first point of contact for low-acuity health care needs where access to alternative primary health care services is lacking, particularly in rural areas. Recent analysis of available data and stakeholder consultation has identified that deficiencies in available after hours services and an inability to access primary care services during business hours provide a barrier to appropriate health care seeking behaviour across the PHN region.

By supporting local innovative solutions to after hours health care needs, the PHN will aim to increase the availability of high quality, locally relevant and effective health care services in the after hours period and subsequently reduce the burden on the region's EDs by:

- Partnering with local health care professionals to co-design and co-commission models that address after hours local level

service needs

- Enhancing existing services, particularly those with models aimed at assisting priority populations and in rural areas, to increase after hours service capacity

Note complimentary activities will assist in improving plans of care and self-management while recognising the complex interplay between patients, carers and service providers after and in hours.

It is also widely recognised that after hours services should be integrated and coordinated to achieve continuity of care between after hours service providers and a patient’s regular GP. This has been identified as being particularly important where patients have chronic or complex conditions, lack access to services, or experience barriers to self-managing their condition.

To achieve continuity of care, CCQ will implement an integrated Virtual Front Door model of care, leveraging existing national infrastructure and systems (Health Direct) to support care navigation for consumers, and triage patients to provide access to timely care based on risk and disposition. This model will support effective communication across providers, and between primary care providers and Hospital and Health Services (HHS). This activity will enhance continuity of care – directing consumer to their regular GP as appropriate, enhancing access to their regular GP for urgent next-day care, and supporting consumers to connect with a regular GP where they do not have one. The mode will ensure timely handover of clinical information to support care continuity between After hours service providers, (including urgent care centres) and a patient’s regular GP by promoting use of digital health mechanisms to promote appropriate information sharing, efficient referral pathways and consistent patient health data collection for accurate record management.

CCQ will also continue to develop and establish innovative digital, virtual and local care models and referral systems (such as telehealth), to improve access and appropriate use of health care services for priority populations during the after-hours period.
