Improve timely access to primary health care professionals to avoid potentially preventable hospitalisations.

Description of Activity *

Timely access to primary health care professionals, whether through face-to-face consultation or telehealth, is recognised as an issue for many RACFs, that in some cases can lead to potentially preventable hospitalisations. RACFs require adequate telehealth facilities to support access to virtual consultations for their residents.

This activity will include:

- partnerships with RACF providers
- assessment of telehealth facilities, equipment and staff capabilities
- implementation of new facilities and equipment (based on need)
- tailored training and support
- strategies to encourage the increased use of My Health Record in RACF
- facilitation of multidisciplinary collaboration (primarily between RACF and their visiting GPs).

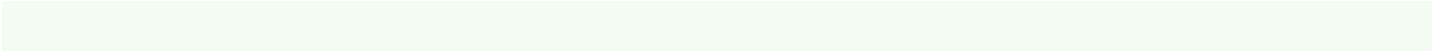

Support older people, who live in residential aged care facilities, to access primary health care services for needs that may arise unexpectedly in the after hours period.

Description of Activity *

RACF residents can experience deterioration in their health during the after hours period, but immediate hospital transfer is not always clinically necessary. Lack of awareness and utilisation of out of hours services provided by GPs and other health professionals leads residents to unnecessary hospital presentations.

RACFs (and other professionals such as General Practitioners) will be engaged in a number of different strategies including:

- Education on after hours health care options and pathways, processes for residents and utilisation of digital medical records
- Support to develop appropriate after hours plans
- Facilitation of engagement between RACF and their residents GPs (and other health professionals) as part of after hours action plan development
- virtual clinical support options

To establish and maintain a network of Care Finders to provide specialist and intensive assistance to help people within the Care Finder target population to understand and access aged care and connect with other relevant supports in the community.

Description of Activity *

The aged care system is complex, and some people find it more difficult than others to navigate and access the services they need. The Care Finders Program will continue to be delivered through the commissioning of new care finder services based on local needs and supporting the transition of the Assistance with Care and Housing (ACH) program to PHNs. This activity will also focus on opportunities to enhance integration between the local health, aged care and other systems.

CCQ will continue to facilitate and maintain a Community of Practice (CoP) for commissioned local Care Finder organisations to build cross organisation networks, establish cross provider referral pathways, and allow sharing of local experiences, lessons learned, innovations and key findings in relation to the service.

CCQ will appropriately contract manage all commissioned Care Finder organisations ensuring:

- appropriate data collection in line with the minimum data set, online reporting tool, and contracted reporting requirements;
- promotion and completion of Care Finder client surveys and appropriate response;
- ongoing monitoring and management of performance;

- supporting issues that arise locally, such as workforce.

The PHN will continue to collaborate with other PHNs across the country through the established 'PHN Care Finders working group' to allow shared experiences, lessons learned and potential innovations. We will also continue to work collaboratively with all contracted Care Finder organisations to support the implementation and ongoing success of the Care Finder, including supporting appropriate in-take processes and supporting training and skills and knowledge development for providers as indicated.

Utilising the current Needs Assessment, published 'Healthy Ageing Strategy 2022 – 2027', stakeholder and community surveys and supplementary health needs assessment CCQ have identified the following sub-groups of the care finders target population as being prioritised for care finder support:

- Aboriginal and Torres Strait Islander people
- Culturally and linguistically diverse people
- People who identify as part of the LGBTIQ+ community
- Care leavers
- Forgotten Australians
- People who are experiencing social isolation
- People experiencing cognitive impairment
- People experiencing homelessness or who are at risk of homelessness
- People with low literacy

The PHN will continue to increase awareness of Care Finders services among General Practitioners, primary health care more broadly, and community organisations through:

- developing and maintaining local referral pathways;
- embedding developed pathways within the PHNs 3 Health Pathways sites and promoting these; and
- ensuring contracted providers directly undertake adequate promotion of their service to community referrers and intermediaries.

CCQ have contracted and funded three providers to date, with services provided within Central Queensland, Wide Bay and the Sunshine Coast regions.
